In addition, the CSRT is a respected collaborator and facilitator by national health organizations, provincial regulatory bodies, industry, and governments.

The second strategic direction aims to provide the highest possible value and services to its members within the resources available. The CSRT has effectively developed programs to advance the profession – whether it is through the Fellowship program, the implementation of an on-line CPD credit tracking system, the on-line education platform, low cost professional liability insurance, position statements, or setting up a research fund. As a result of the quality services and programs offered by the CSRT, we have seen an increase in the membership, an indication that the CSRT offers good value to its members. The third strategic direction provides direction for the promotion of the profession. ## **ADVOCATE ON BEHALF OF THE PROFESSION**

The CSRT will be an effective advocate for the RT Profession, the health care system and the quality of patient care.

**OBJECTIVE:** To increase the influence of the CSRT with internal and external stakeholders in the health care system.

#### NATIONAL MOBILITY AGREEMENT

The CSRT provided leadership in establishing a National Mobility Agreement between regulated and non-regulated jurisdictions. Working with regulatory bodies, members of the National Alliance of Respiratory Therapy Regulatory Bodies, the CSRT helped create and promote labour mobility for respiratory therapists from unregulated jurisdictions to employment opportunities in six of the seven regulated provinces – in keeping with the principals of the Agreement on Internal Trade. This Agreement facilitates labour mobility while protecting the public. It is one more step towards the harmonization of standards in the practice of respiratory therapy in Canada.

#### STANDING COMMITTEE ON HEALTH REVIEWS LESSONS LEARNED FROM H1N1 PANDEMIC

The federal government's Standing Committee on Health has a mandate to review national health issues and will be discussing lessons learned from the H1N1 Pandemic. The CSRT President has sent a letter to Joy Smith, M.P., Chair of the Standing Committee on Health, to provide information on the role of the profession during the H1N1 pandemic and to request that respiratory therapists be included in discussions surrounding health human resources and equipment resources, such as the ventilator stockpile requirements during a pandemic. The CSRT calls for continued pandemic planning and the allocation of appropriate resources and budget allocations be directed towards it. We reiterated our concern about the lack of harmonization between federal, provincial and institutional guidelines and called for national standards for infection control practices and access to personal protective equipment. The CSRT shared its evidence-based position statement on the use of aerosolgenerating medical procedures as an example of national statements that proved useful to the profession during the H1N1 pandemic.

#### FEDERAL GOVERNMENT REPORT ON HEALTH HUMAN RESOURCES

The CSRT has received a copy of the report finalized in June by the Standing Committee on Health week entitled "Promoting innovative solutions to Health Human Resources Challenges". The report includes 29 recommendations, some of which are relevant to the respiratory therapy profession. Working with HEAL (Health Action Lobby Group), the CSRT reviewed the report and formulated a response submitted to Health Canada as well as to the Standing Committee on Health.

#### WORKING WITH THE NATIONAL ALLIANCE OF REGULATORY BODIES

The CSRT is an important member of the National Alliance of Regulatory Bodies and administers projects funded by the federal government that will lead to a common national process for credential, prior-learning and competency assessment of internationally educated health professionals who want to work in Canada as respiratory therapists. The CSRT also participates in discussions that will lead to the harmonization of registration requirements across all jurisdictions. Another project aims to evaluate the equivalency between the American (NBRC) and Canadian (CBRC, L'Épreuve synthèse) certification examinations. Should the exams prove to be equivalent, this may facilitate the implementation of a new reciprocity agreement between the US and Canada.

#### 2011 NATIONAL COMPETENCY PROFILE

The CSRT was a collaborator in the development of the 2011 National Competency Profile. The National Alliance of Respiratory Therapy Regulatory Bodies recently launched the 2011 National Competency Profile has been developed in consultation with stakeholders and the CSRT.

#### NATIONAL EDUCATIONAL FRAMEWORK FOR ANESTHESIA ASSISTANTS

The CSRT participates in the CAS Task Force on Anesthesia Assistants. This CAS task force has completed a document to provide the foundation for curriculum development and act as a resource for further development of the growing profession



of anesthesia assistants. This document may also provide a useful basis for the development of competency requirements for anesthesia assistants and may lead to the development of written and practical examinations and the development of a national accreditation process for AA education programs.

# **OBJECTIVE:** To increase the profile of the CSRT with internal and external stakeholders.

The CSRT participates in several national projects, including the following initiatives:

#### CANADIAN NETWORK FOR ASTHMA RESPIRATORY CARE PROJECT

A project of the Canadian Network for Asthma Respiratory Care entitled "Enhancing health care providers' capacity to integrate evidence based smoking cessation interventions into practice settings across Canada". The project aims to establish certification standards and an examination for a national Certified Smoking Cession Educator designation and developing evidence-based national learning objectives and smoking cessation training curriculum.

#### **MECHANICAL VENTILATOR WEANING PROJECT**

A University of Toronto project on mechanical ventilator weaning that aims

- (1) to review the literature on weaning methods, weaning venues, care models and patient outcomes;
- (2) to synthesize qualitative research to identify factors affecting the use of weaning protocols and help to explain outcomes across studies, and
- (3) to synthesize evidence from trials evaluating automated weaning systems in adults and children to elucidate the true effect of a standardized weaning process.

#### LONG-TERM MECHANICAL VENTILATION IN CANADA: A PROGRAMMATIC APPROACH PROJECT

A University of Toronto project entitled "Understanding Long-Term Mechanical Ventilation in Canada: A Programmatic Approach". The project will address clinical practice, health care policy, and knowledge generation and translation across the continuum of care and across the country.

#### **COLLEGE OF FAMILY PHYSICIANS OF CANADA**

The College of Family Physicians of Canada has asked the CSRT to participate in their project entitled *"Educational outreach to primary healthcare professionals regarding the Air Quality Health Index"*. The project aims to educate primary healthcare practitioners about the health effects of air pollution and provide information and tools to incorporate in their clinical practice.

# CONSUMER SESSION AT ANNUAL EDUCATION CONFERENCE

As part of the CSRT out-reach to the community, a consumer session on sleep apnea was offered to the public, prior to the CSRT annual Education Conference and Trade Show in Newfoundland. This information session *- Obstructive Sleep Apnea* was presented by a respiratory therapist and was well attended by the public.

#### H1N1 SURVEY RESULTS PROVIDED

Results from a November 2009 H1N1 survey were released. Over 500 people participated in the *Respiratory Therapists and H1N1 Infulenza A Pandemic* survey and the results were posted on the CSRT website. This survey was developed in conjuction with professional practice experts.

**OBJECTIVE:** To ensure the CSRT produces and disseminates evidence-based and/or expertise-based material.

#### **POSITION STATEMENT ON "LEVELS OF PRACTICE"**

The CSRT continues to produce material for RTs including the December 2010 position statement on "Levels of Practice" which discusses the adaptation of the levels of practice for RTs to meet the needs of a complex and evolving health care delivery system.

**OBJECTIVE:** To ensure CSRT has a presence at key provincial and international conferences and meetings.

The CSRT continues to be a representative on a variety of national task forces and projects to advance the profession.

#### **PROVINCIAL RT CONFERENCES**

The CSRT makes efforts to provide a presence at provincial conferences. In 2010 the CSRT has participated in the College and Association of Respiratory Therapists of Alberta (CARTA); the Ordre des inhalothérapeutes du Québec.

#### NATIONAL MEETINGS

The CSRT is a key stakeholder and participates regularly in meeting of several national stakeholders including: National Alliance of Respiratory Therapy Regulatory Bodies; Heal Action Lobby Group (HEAL); Royal College of Physicians and Surgeons; Canadian Forum on Health Science Education; Lung Association; Canadian Anesthesiologists' Society; The Association of Community Colleges in Canada.

#### **INTERNATIONAL MEETINGS**

The CSRT participated in the 2010 Intentional Respiratory Congress of the American Association of Respiratory Care. The CSRT also plays an essential role on the International Council for Respiratory Care.

### **BUILD THE CSRT MEMBERSHIP**

The CSRT will provide the highest possible value and service to its members

**OBJECTIVE:** To enhance the communication tools and process.

#### **CANADIAN JOURNAL OF RESPIRATORY THERAPY**

With the transition of the Canadian Journal of Respiratory Therapy to a knowledge-based journal, the CSRT has provided an excellent new venue for dissemination of peer-reviewed papers, case studies, book reviews and directed readings. The journal is available online as well as sent to individuals who request it.

#### **CSRT MONTHLY NEWSLETTER**

For information on activities within the CSRT, a monthly membership newsletter has been created to keep members abreast of new initiatives, services and information introduced by the Society. This newsletter is available on-line and sent out via mail to members who request it.

# **OBJECTIVE:** To enhance access to bilingual programs and services.

The CSRT continues to provide as much service as possible in both official languages.

# **OBJECTIVE:** To enhance access to programs and services by maximizing the use of on-line technology.

#### **CSRT STUDENT MEMBERSHIP**

To streamline the membership process for students, an on-line registration process was implemented. Students can now become members for a one-time fee of \$100.00 which covers them for their entire student life.

#### CSRT NEWSLETTER AND JOURNAL ACCESSIBLE ON-LINE

In order to provide environmentally and technology-friendly atmosphere, the CSRT has made the newsletter and journal available on-line. The files are printable as well. Members who wish, can still receive a paper copy.

#### **CSRT PURCHASES ONLINE EDUCATION PLATFORM**

After investigating the feasibility of various on-line education platforms, the CSRT purchased the rights to the web site www.respiratoryresource.ca constructed by respiratory therapist Tom Piraino. The web site offers a public section that will include the current material already available on public websites. CSRT members have exclusive access to additional educational material for all areas of practice. This CSRT Members-Only section will include a catalogue of guidelines, policies, medical directives distributed through the professional practice listserv; case studies and case presentations; discussion forum tailored to the needs of each area of practice; new tutorials and video presentations of interest to each area of practice; respiratory therapy areas; reviews and discussions on current literature; monthly free Webinars. The CSRT acknowledges the education grant provided by Ikaria Canada Inc. for the establishment of a CSRT on-line education platform.

#### TRACKING EDUCATION CREDITS ON-LINE

The CSRT has developed an on-line platform to track education credits. The platform was originally developed for use by CSRT Fellows to track their education credits and it will also be a useful tool for all respiratory therapists to track their professional development activities.

#### CSRT PARTNERS WITH OPIQ FOR ACCESS TO AWARD WINNING ON-LINE EDUCATION PLATFORM

The CSRT has provided a grant to the Ordre des inhalothérapeutes du Québec to translate some on-line courses available on their award-winning CAMPUS. OPIQ has recognized the CSRT contributions by providing access to CSRT members to their on-line interactive courses, most notably the course on pulmonary auscultation. The partnership agreement is to be finalized for announcement at the 2011 AGM. **OBJECTIVE:** To maximize the membership services and ensure the long-term viability of the organization.

The CSRT has undertaken new initiatives to secure more services of value to the membership.

#### **COMPLIMENTARY WEBINARS**

A complimentary webinar was presented on March 18 entitled: Risk Management and Malpractice Trends for RTs. On November 18, a webinar was presented by Dr. Paul Hernandez entitled: *Pulmonary Rehabilitation*, presented by Dr. Paul Hernandez. In addition, a series of complimentary webinars were available to CSRT members during RT Week, including:

**Closed loop control of ventilation and/or oxygenation** – Richard Branson, RRT

Tobacco addiction: What do we know and where do we go? – Dr. Charl Els

Liability Insurance: What you should know - Brian Gomes

#### **MEMBERS-ONLY SECTION CSRT WEBSITE**

A Members-Only section added to the CSRT website to provide exclusive access to areas like the CJRT, listservs, Catalogue of Guidelines and information on the annual general meetings.

#### LUNCH AND LEARN SESSIONS

A series of "Lunch & Learn" sessions was held in the Ottawa area to inform respiratory therapists on the value of professional liability insurance, the benefits of membership to a professional association and the distinct roles of the CSRT and regulatory bodies.

# REDUCTIONS IN COST OF PROFESSIONAL LIABILITY INSURANCE

Professional Liability Insurance continues to have great value and in 2010 the CSRT negotiated further reductions in cost and while coverage was enhanced.

**OBJECTIVE:** To ensure the management of the CSRT meets the benchmarks of excellence for association management.

### **PROMOTE THE PROFESSION**

The CSRT will support and promote the professional image of respiratory therapists.

**OBJECTIVE:** To reinforce a positive professional culture for respiratory therapists.

#### **RESPIRATORY THERAPY WEEK OCTOBER 24 – 30, 2010**

Promotional items were created to help promote Respiratory Therapy Week in October, Materials were made available free of charge to CSRT members including materials for practicing RTs to help promote the profession – RT pins; calendar posters; lanyards. As well respiratory therapists had access to a large RT Week display banner and give-aways to the public – magnetic book marks, card-sized calendar/fact sheet and "What is an RT?" brochures. As well a series of complimentary webinars was offered to members.

Respiratory therapists were very positive in promotion the profession. Orders from 139 members were received for the complimentary items. Many sent back reports and photos of their RT Week activities to be included in the November newsletter.

**OBJECTIVE:** To support the professional image of the CSRT members.

#### CSRT CREATES NEW FELLOWSHIP DESIGNATION - FCSRT

The CSRT implemented a Fellowship designation (FCSRT) to recognize registered members who have been loyal members of the CSRT and have made a significant and consistent contribution to the development of the science and profession of respiratory therapy. CSRT Fellows will receive a certificate and a FCSRT pin.

#### **FIRST ANNUAL RUN FOR RESEARCH**

The first annual "Run for Research" was held at the Education Conference in Newfoundland. Funds collected went to support RT doing research. Ten brave runners showed up early Sunday morning, May 16, 2010, to run the 2.5KM course around the St. John's harbour front. They collected over \$1000.00 for research. Allan Shemanko, CARTA President and President of the NARTRB, won the prize for raising the most money.

#### **CSRT AWARDS**

With the help of industry partners, the CSRT promotes student achievements, as well and recognizes members of the RT community who have helped promote the profession and the Society.



### **Foster National Professional Standards**

The CSRT will encourage professionalism in the practice of respiratory therapy and optimize practice requirements for RTs

**OBJECTIVE:** To be proactive in the management of issues that impact the professional practice of RTs.

#### **CERTIFICATION FOR SPECIFIC AREAS OF PRACTICE**

An outline of the certification process was developed for anesthesia assistants. The process to develop and implement a certification program was presented to the Board of Directors for review. The Board of Directors supports the development of certificates.

#### NATIONAL ALLIANCE MEETINGS

The CSRT was represented at meetings and discussions with the National Alliance, as well as a meeting between the National Alliance and the CAS Board to discuss issues from previous meetings. The CSRT continues to work with its partners in creating long-term national strategies.

#### **NBRC – CBRC MEETINGS**

The CSRT is working on a project to determine the equivalency between the American and Canadian certification examinations. Should these exams prove to be equivalent; this will facilitate the negotiation of a new reciprocity agreement between the two countries. It is anticipated this evaluation process will be complete in 2011.

#### DEVELOPMENT OF COMPANION DOCUMENTS FOR EDUCATORS

The CSRT obtained funding and worked with key stakeholders in the education process to develop national guidelines for educators. The companion document and competency evaluation templates for the 2011 National Competency Profile were disseminated in December 2010. **OBJECTIVE:** To ensure the practice of the profession meets the highest standards and meet the needs of the current practice environment.

#### LEVELS OF PRACTICE POSITION STATEMENT

The CSRT developed a position statement on levels of practice as recognition of the evolving practice of respiratory therapy. The profession faces many challenges, including shortages of health care professionals, an aging population, increased incidence of chronic respiratory disease, the introduction of new technology and challenges relative to patient access and the ability to provide quality and comprehensive respiratory care. As the profession of respiratory therapy will continue to evolve and the level of practice will be adapted to meet the needs of a complex health care delivery system, the CSRT recognized the need to provide definitions of levels of practice. This statement was disseminated to members, regulatory bodies, CoARTE, CBRC, CACERT members through a variety of communication tools.

#### **RT TO VENT RATIO PROJECT**

The CSRT developed a survey to collect data on RT to VENT ratio. An information workgroup was established that included RTs from across the country. The project activities included a literature search and the implementation of a survey. The survey was implemented in May of 2011.

#### **2010 CSRT STUDENT ACHIEVEMENT MEDALS**

The CSRT awards recognize CSRT student members with the highest mark on the CBRC examination. Awards were presented at the President's Banquet at the annual Education Conference in Newfoundland. **Gold Medal – Deanna Simons** Thompson Rivers University, British Columbia **Silver Medal – Genevieve Tozer**, Algonquin College, Ontario **Bronze Medal – Dana Dryfhout** Thompson Rivers University, British Columbia

#### MISSION OF THE COUNCIL ON ACCREDITATION OF RESPIRATORY THERAPY EDUCATION

The mission of the Council on Accreditation for Respiratory Therapy Education (CoARTE) is to promote the highest quality of respiratory therapy education through accreditation services.

#### MESSAGE FROM THE CHAIR OF COARTE Donald Reid, MD, FRCP(C)

As I complete my term as Chair of CoARTE, I would like to thank all of the council members and the CSRT Board of Directors for entrusting me with this role over the past two years. This report is an opportunity to review the previous year, and to thank the many contributors to accreditation of education in the respiratory therapy profession. My gratitude goes in particular to the program reviewers, who give their time with generosity and commitment, in order to advance the profession and the educational standards.

In 2010 CoARTE managed five accreditation visits, among them an international one. Such an amount of work would not have been possible without the commitment and dedication of the volunteers, who came through even in particularly difficult situations. 2010 was the year when four of the six francophone programs in the province of Quebec were accredited by CoARTE for the first time. There is a new draft for the self-study template, which was developed by CoARTE and will be finalized with the help of the experienced program reviewers and program coordinators. First steps towards a working bilateral relationship between CoARTE and the National Alliance of Respiratory Therapy Regulatory Bodies were taken. We hope this opens a fruitful collaboration.

I would like to greet Carolyn McCoy as incoming chair of CoARTE and Susan Dunington as vice-chair; I also wish to welcome the new members Christina Sperling (employer representative) and Peter Murray (public representative). I would also like to thank Lindsay Schroeder and Neil Johnston for their activity on the Council, and wish them well in their future endeavours.

#### UPDATE ON THE ACCREDITATION REVIEW

Following the recommendations from the consultants in the fall of 2009, the council modified the accreditation calendar to better suit the needs of the educators. Thus, the annual report will be now submitted in the spring instead of the fall. New templates for the annual report were developed, too, and they are already in use. New templates for the self-study documentation completed by the programs have also been developed and are in the process of being finalized. For all the new templates, CoARTE has invited feedback from the program reviewers and from school representatives involved in the accreditation process.

#### **CONSULTATION WITH STAKEHOLDERS**

Carolyn McCoy and Susan Dunington represented CoARTE at the stakeholders' meeting in St. John's, NL, in May 2010, concluding the development of the new National Competency Profile. There also was an informal meeting between CoARTE and member of the National Alliance, discussing the requirements of accreditation and the process. CoARTE was invited at the Alliance meeting in Quebec City, in June 2011, to give a presentation of the CSRT accreditation process. CoARTE, through its vice-chair Carolyn McCoy and accreditation manager Milena Cotinghi, were invited to a consultation meeting by the College of Respiratory Therapists of Ontario regarding the process of integrating internationally trained professionals (RTs) into the Canadian workforce (November 2010).

#### **PARTICIPATION IN SPECIAL PROJECTS**

The CSRT and CACERT worked in close collaboration with the National Alliance of Respiratory Therapy Regulatory Bodies (NARTRB), the Canadian Board for Respiratory Care (CBRC) and CoARTE to develop an educators' tool: the companion document to the 2011 National Competency Profile. This document was finalized and will be in use when the new NCP will be implemented.

#### INTERNATIONAL ACCREDITATION

The first accreditation visit to an international program took place in 2010. The program in Qatar received the

accreditation team at the end of March. The program was accredited. Two students from this program participated in the CSRT conference in May, in St. John's, NL, and impressed their Canadian peers with their knowledge and skill.

#### ASSOCIATION OF ACCREDITING AGENCIES OF CANADA

CoARTE continues to be a member of AAAC (Association of Accrediting Agencies of Canada), which is a very important resource for best practices in accreditation. In 2010 there were two meetings, in the spring and fall. The topics discussed are of great interest for the current accreditation challenges. Some examples included: retention of accreditation records; quality control; communication; volunteer burnout and motivation; good practices in program accreditation; reducing paper through automation and on-line procedures; international accreditation; outcome-based versus competency-based accreditation. Being a member of the AAAC provides access to a valuable pool of information and materials. Members share templates, procedures and guidelines. A consultation process is also available.
