The Council on Accreditation for Respiratory Therapy Education (CoARTE) is seeking applications for two volunteers to fill the upcoming vacancies:

### **AA Certification Update**

The implementation of a national certification process for Anesthesia Assistants is moving forward. Over the past year, the Interprofessional AA Certification Workgroup established and validated the AA National Competency Framework and developed the exam matrix. We have now established an Interprofessional AA Exam Committee who met on February 24-25 to start developing the national AA Exam questions. The Committee will finalize the development of the AA exam questions at their next meeting on May 26-27, 2017. The first national AA exam will be held on March 26, 2018 and will be offered to new AA program graduates who have completed both didactic and clinical education.

The CSRT will continue to offer the Certified Clinical Anesthesia Assistant (CCAA) professional designation to AAs who have graduated from AA education programs prior to March 2018. The CCAA professional designation is also offered to individuals who have achieved equivalent clinical knowledge and skills (over 5 years) working exclusively in anesthesia and can provide an attestation from their immediate supervisor that they have achieved the competencies outlined in the 2016 National AA Competency Framework.



### More courses approved for CSRT CE/CPD credits!

### **Private Practice Update**

The CSRT has been working to overcome barriers to RTs entering private practice. Last year, the CSRT develop a toolkit for RTs wishing to enter this realm. #### **Deadline approaching for CCAA applications**

The deadline for applications for the Certified Clinical Anesthesia Assistant (CCAA) designation is **April 30**. The CCAA replaces the AA-CSRT which was launched in May 2014 to recognize CSRT registered and associate members who have completed additional education and clinical training in the field of anesthesia to become an anesthesia assistant, who demonstrate involvement in professional development activities and are committed to maintaining proficiency and professionalism as an anesthesia assistant. CSRT members who have completed an approved anesthesia assistant program or who have can demonstrate that they are able to perform the competencies in the 2016 National Competency Profile for Anesthesia Assistance are eligible for this designation.
